Town Board recommends a change to the zoning ordinance that would allow the Ag-res district to change to a minimum of 2.5 acre building lots, while maintaining the 5 acre average home average for the entire parcel being divided. The purpose of this change would be to promote greater contiguous tillable farm acreage, wild life conservation and forest conservation in Forest by allowing building sites to be slightly closer together while maintaining the 8 homes per 40 acre density in the current zoning ordinance. By design, every 2.5 acre home requirement (or any site less than 5 acres) elected (for example) would increase the non-buildable acreage (for tillable acreage, pasture acreage, wild life acreage, or Forest acres, by An equal amount). The idea is that this is more efficient and less wasteful from an agricultural, wild life conservation, and forest conservation viewpoint which is consistent with the town's Comprehensive plan and It is intended that this change while not increasing earlier approved density in the zoning ordinance will give farmers and conservationists alike, an additional tool to preserve contiguous tillable acreage or wild life or forest acres. Board members may discuss and recommend other zoning ordinance changes for recommendation to the planning commission at this meeting.
